Course Content

By the end of this course, students will gain a comprehensive understanding of conventional printmaking methods such as Relief and Intaglio printmaking. They will not only grasp the historical and cultural significance of these techniques but also apply them in both artistic and design contexts. Students will explore the relationship between traditional printmaking and modern commercial industries, such as packaging and textile design, and critically analyze works from various artistic movements, including **Ukiyo-e**, **Renaissance**, **La Belle Epoque**, **Art Nouveau**, **Art Deco**. The course will also emphasize the technical aspects, including advanced color separation techniques, typography in printmaking, and the importance of craftsmanship.
